The author's last name and the work's date of publication must always appear, and these items must match exactly the corresponding entry in the references list. The third kind of information, the page number, appears only in a citation to a direct quotation.

When citing books, videos, brochures, journals, reports, etc. italicize the title. When citing web pages, journal article titles, or chapter titles use quotation marks around the title.

Citations are placed in the context of discussion using the author's last name and date of publication. When a work has no identified author, cite in text the first few words of the article title using double quotation marks, “headline- style” capitalization, and the year. (“Barcelona to Ban Burqa,” 2010)
